Palliative Provider Member Rates

Provider member dues for 2022 are based on the number of patients your program served in 2020. The cost of membership is:

Less than 100 patients = \$300/year membership

101 - 300 patients = \$500/year membership

301-501 patients = \$750/year membership

501 or more patients = \$1000/year membership

Individual Palliative Provider Membership = \$100/year
