### Traveling on I-94 from the South:

Take exit 171 off I-94 to Roosevelt Road.

Turn right onto 33<sup>rd</sup> Street South.  
Continue onto Clearwater Road.  
Destination will be on the left.

### Traveling on I-94 from the North:

Take exit 171 off I-94 to Roosevelt Road.  
Turn left onto Roosevelt Road (signs for Stearns County 75 N).  
Turn right onto 33<sup>rd</sup> Street South.  
Continue onto Clearwater Road.  
Destination will be on the left.

### Traveling on Hwy 15 from the South:

Take the exit toward 33<sup>rd</sup> Street South.  
Turn right onto 33<sup>rd</sup> Street South.  
At the traffic circle, take the 2<sup>nd</sup> exit and stay on 33<sup>rd</sup> Street South.  
Again, at the traffic circle, take the 2<sup>nd</sup> exit and stay on 33<sup>rd</sup> Street South.  
Continue onto Clearwater Road.  
Destination will be on the left.

### Traveling on Hwy 15 from the North:

Turn left onto 2<sup>nd</sup> Street South. Continue onto Roosevelt Road.  
Turn left onto Sportsman's Island Road.  
Turn right onto Clearwater Road  
Destination will be on the right.
